

Platform Terms of Use

PLEASE NOTE: THESE TERMS OF USE CONTAIN AN ARBITRATION AGREEMENT.

Thank you for using Intermodal Pool!

These Terms of Use (“**Terms**”) are a binding and legal agreement between you and Intermodal Pool that govern your right to use the websites, applications, forms, and other offerings from Intermodal Pool (collectively, the “**Platform**”). When used in these Terms, “**Intermodal Pool**,” “**IMP**,” “**we**,” “**us**,” or “**our**” refers to Intermodal Pool LLC.

The IMP Platform offers an online venue that enables users (“**Members**”) to publish, offer, search for, and book “**Equipment**” and “**Services**.” Members who publish and offer Equipment or Services are “**Vendors**” and Members who search for, book, or use Equipment or Services are “**Customers**.” You must register an account to access and use many features of the Platform, and you must keep your account information accurate. As the provider of the Platform, Intermodal Pool does not own, control, offer or manage any Listings or Vendor Services. IMP is not a party to the contracts entered into directly between Vendors and Customers. IMP is not acting as an agent for any Member except as expressly stated for limited payment collection purposes as described in these Terms of Use.

We maintain other policies that supplement these Terms like our Privacy Policy, which describes our collection and use of personal data.

If you are a Vendor, you are responsible for understanding and complying with all laws, rules, regulations and contracts with third parties that apply to your Vendor Services.

Definitions

“Account”

means the single account identified to a Member which results from a Member registering for an Account through the Platform. No Member may have more than one Account.

“Reservation”

means, pursuant to a Confirmed Reservation and Reservation Agreement, a limited license granted by the Vendor to the Customer for use of Equipment for the limited duration of the

Confirmed Booking or a provision of Services by a Vendor for a Customer pursuant to a Confirmed Booking and Booking Agreement.

“Reservation Agreement”

means a limited license agreement entered into via the Platform by a Vendor and Customer pursuant to Vendor’s Confirmed Reservation of Equipment or Services. Intermodal Pool is not a party to the Booking Agreement. Vendor shall upload to the Vendor Profile the form of Reservation Agreement that Vendor desires to use with Customers.

“Reservation Fee”

means the amount established by a Vendor in its Vendor Profile for use of the Equipment or provision of Services, which is usually expressed as a daily rate (e. g. , \$20 per chassis per day or portion thereof) for Equipment and a one time fee for Services (e.g., \$100 for a BIT inspection on 1 chassis). The Vendor, and not Intermodal Pool, is responsible for setting the Reservation Fee for the Equipment or Service. If Vendor determines that any Taxes are required to be collected in connection with a Booking or Reservation Agreement, Vendor is solely responsible for determining, charging, collecting, reporting, and remitting such Taxes to the applicable taxing authority. The Reservation Fee payable by Customer also includes the IMP Fees.

“Booking Request”

means the request by Customer to Book Equipment or Services pursuant to the Vendor Profile, as evidenced by Customer clicking the “Purchase” or similar button on the Website.

“Customer”

means a Member who reserves Equipment or Services through a Booking Agreement with a Vendor via the Platform, or any agent of a Member who uses the Equipment or Service and is not the Vendor for the associated Vendor Profile.

"Collective Content"

means Member Contributions and Intermodal Pool Content.

“Confirmed Reservation”

means that a Vendor has accepted a Customer’s Reservation Request.

"Communication"

means an email or message via the Platform.

“Content”

means graphics, audio, video, information, text, images, music, software (excluding the Platform) or other materials.

“Equipment”

means chassis, trailer, container, truck, genset, or any other physical item that is booked by a Customer from a Vendor on the Platform.

“Losses”

means claims, losses, damages, obligations, liabilities, debts and expenses, including but not limited to reasonable fees of attorneys, accountants and expert witnesses.

“Member”

means a Person who completes Intermodal Pool’s Account registration process.

“Member Contributions”

is defined in the Member Contribution section of these Terms of Use.

“Payment Method”

means a method of payment that a Member has added to its Account, for example, debit card, credit card or ACH through the Stripe dashboard.

“Person”

means an individual, corporation or other legal entity.

“Platform”

means collectively the websites, applications, forms, and other offerings from Intermodal Pool.

“Service”

means maintenance or repair work that is completed by a Vendor for a Customer.

“Intermodal Pool Content”

means all Content that Intermodal Pool makes available through the Platform or its related promotional campaigns and official social media channels, including any Content licensed from a third party, but excluding Member or other user Content.

“Intermodal Pool Parties”

means Intermodal Pool, its affiliates, licensors, and service providers, and its and their respective officers, directors, employees, contractors, agents, licensors, vendors, successors, and assigns.

“IMP Fees”

means the fee that Intermodal Pool charges to a Vendor for the use of the Platform when a Vendor confirms a Reservation.

“Stripe”

means Stripe, Inc.

“Vendor”

means a Member who creates a Vendor Profile via the Platform.

“Vendor Profile”

means Vendor’s listing and description of Equipment and / or Services, features thereof and other information that is listed by a Vendor as available for Booking via the Platform.

"Tax" or "Taxes"

mean any sales taxes, goods and services taxes (GST), or other taxes and fees that Vendors may be required by law to collect and remit to governmental agencies, and other similar municipal, state, federal and national indirect or other withholding and personal or corporate income taxes.

"Website"

means www.intermodalpool.com.

Acceptance of the Terms of Use

Intermodal Pool, LLC and its affiliates ("Intermodal Pool", "IMP," "we" "us," or "our"), provides the IMP Platform which connects Vendors who have Equipment or Services available for Booking and Customers who seek to Book such Equipment or Services under a Booking Agreement. Bookings are made directly between Vendors and Customers via the Platform. Customers must pay all Booking Fees to Intermodal Pool via Stripe. After Customer has made such payment for the Booking Fee to Intermodal Pool through Customer's Stripe account, the IMP Fee is deducted from Booking Fee by Intermodal Pool and the remaining balance is then disbursed to the Vendor by Intermodal Pool through Stripe. **ACCORDINGLY, YOU AGREE THAT (I) Intermodal Pool IS NOT A PARTY TO ANY AGREEMENTS ENTERED INTO BETWEEN VendorS AND CustomerS; (II) Intermodal Pool IS NOT A REAL ESTATE BROKER, AGENT OR INSURER; (III) Intermodal Pool HAS NO CONTROL OVER THE CONDUCT OF VendorS, CustomerS, EQUIPMENT, SERVICES, OR OTHER CustomerS OF THE Website; (IV) Intermodal Pool HAS NO CONTROL OVER THE CONDUCT OF STRIPE; AND (V) Intermodal Pool DISCLAIMS ANY AND ALL LIABILITY AND OBLIGATIONS IN THIS REGARD TO THE MAXIMUM EXTENT PERMITTED BY LAW.**

These Terms of Use are entered into by and between you and Intermodal Pool. The following terms and conditions, together with any documents they expressly incorporate by reference (collectively, these "**Terms of Use**"), govern your access to and use of www.intermodalpool.com, including any Content, functionality, and services offered on or through www.intermodalpool.com (the "**Website**"), and applications for mobile, tablet and other smart devices and application program interfaces (collectively, the "**Platform**"), whether as a guest or a registered user.

Please read the Terms of Use carefully before you start to use the Platform. **By using the Platform or by clicking to accept or agree to the Terms of Use when this option is made available to you, you accept and agree to be bound and abide by these Terms of Use and our Privacy Policy, incorporated herein by reference, and these Terms of Use and our Privacy Policy constitute a binding legal agreement between you and Intermodal Pool LLC.** If you do not want to agree to these Terms of Use or the Privacy Policy, you must not access or use the Platform.

This Platform is offered and available to users who are 18 years of age or older, and reside in the United States or any of its territories or possessions. By using the Platform, you represent and warrant that you are of legal age to form a binding contract with Intermodal Pool and meet all of the foregoing eligibility requirements. If you do not meet all of these requirements, you must not access or use the Platform.

Certain areas of the Platform (and your access thereto or use thereof) may have different policies, guidelines or terms and conditions, or may require you to agree with and accept additional terms and conditions. If there is a conflict between these Terms of Use and terms and conditions posted with respect to a specific area of the Platform or Collective Content, then the latter will govern, but only with respect to your use of or access to that area of the Platform or Collective Content.

If you decide to create a Vendor Profile or Book Equipment or Services on the Platform, you agree that your relationship with Intermodal Pool is that of a Vendor or Customer, as appropriate, and an independent, third-party contractor, and you agree that you are not an agent, employee, joint venturer or partner of Intermodal Pool for any reason whatsoever; you act exclusively on your own behalf and for your own benefit, and not on behalf of or for the benefit of Intermodal Pool. Intermodal Pool has no control, and has no right to control, your Vendor Profile or any other matters related to any Vendor Profile. You agree not to do anything to create the impression that you are endorsed by, partnering with, or acting on behalf of or for the benefit of Intermodal Pool and you may not use Intermodal Pool's intellectual property for any reason whatsoever.

You agree that if you accept or agree to these Terms of Use on behalf of an entity that is not a natural person, you represent and warrant that you have the authority to bind that entity to these Terms of Use and that the terms "you" and "your" will refer and apply to that entity.

Changes to the Terms of Use

We may revise and update these Terms of Use from time to time in our sole discretion. All changes are effective immediately when we post them, and apply to all access to and use of the Platform thereafter. However, any changes to the dispute resolution provisions set out in Governing Law and Jurisdiction and Arbitration Agreement will not apply to any disputes for which the parties have actual notice on or before the date the change is posted on the Platform.

Your continued use of the Platform following the posting of revised Terms of Use means that you accept and agree to the changes. You are expected to check this page each time you access the Platform so you are aware of any changes, as they are binding on you. If the revised Terms of Use are not acceptable to you, your only recourse is to stop your use of the Platform, however if you do not close your Account, you will be deemed to have accepted the changes.

Term/Termination/Suspension

These Terms of Use are effective for a thirty (30) day term, which automatically renews for successive 30-day terms until these Terms of Use are terminated as set forth below:

Termination for Breach. Without notice or grace period, Intermodal Pool may terminate these

Terms of Use with you if you breach any provision of these Terms of Use, if you violate applicable laws, or if Intermodal Pool believes that such termination is reasonably necessary to protect the safety or property of Intermodal Pool, other Members, or third parties.

Termination for Convenience. At any time, you may terminate these Terms of Use with Intermodal Pool by canceling your Account by sending an email to info@intermodalpool.com. A Vendor who cancels its Account agrees to honor any Confirmed Bookings. A Customer who cancels its Account agrees to honor any Confirmed Bookings. There will be no refunds in the event that a Vendor or Customer cancels its Account. Intermodal Pool may terminate these Terms of Use at any time by giving you not less than thirty (30) days' notice to your email address that you registered in your Account profile.

Intermodal Pool maintains the ongoing right to temporarily or permanently deactivate or delay Vendor Profiles, review any Member Content, cancel any pending or Confirmed Bookings or limit your use or access to your Account or the Platform if you breached these Terms of Use (whether material or non-material breach), have received poor ratings as a Vendor or Customer, or if Intermodal Pool believes in good faith that such action is reasonably necessary to protect the safety or property of Intermodal Pool, Members, or third parties. If Intermodal Pool takes any of the actions described herein, Intermodal Pool may communicate directly with Customers or Vendors that pending or Confirmed Reservations have been canceled, or assist Customers in finding alternative Equipment or Services. If your Account has been suspended or these Terms of Use have been terminated by Intermodal Pool, you are prohibited from registering a new Account or attempting to access or use the Platform through other means. If you or we terminate these Terms of Use, the provisions that reasonably should survive termination will remain in effect. In no event shall a Member be entitled to any compensation whatsoever for any inaction or action which may be taken by Intermodal Pool pursuant to this Section.

Information About You and Your Visits to the Platform

We may collect certain information about you and from your use of the Platform. All information we collect on or in connection with the Platform is subject to our Privacy Policy, which is incorporated into these Terms of Use. By accessing or using the Platform, you consent to the information collection, use, and sharing described in the Privacy Policy.

You represent and warrant that all information you provide in connection with your access to or use of the Platform is true, accurate, and complete to the best of your knowledge and belief. You represent and warrant that, if you submit the personal information of any person other than yourself in using the Platform, you have sufficient permission from that person to provide us with that information.

Any and all data collected by Intermodal Pool as a result of your access to or use of the Platform, but excluding data consisting of Member Contributions and any personal information, is, as between you and Intermodal Pool and to the extent permitted by applicable law, owned exclusively by Intermodal Pool. Additionally, any and all anonymized and aggregated data created based on or using Member Contributions or personal information is, as between you and Intermodal Pool and to the extent permitted by applicable law, owned exclusively by Intermodal Pool. You acknowledge and understand that Intermodal Pool may, subject to

applicable law and without compensation to you, use Intermodal Pool-owned data in any manner for its business purposes.

Accessing the Platform and Account Security

The Platform can be used by Vendors and Customers to facilitate Vendor Profiles and Reservations with each other. Unregistered users may also view Vendor Profiles, however if you would like to create a Vendor Profile to list Equipment or Services, or make a Reservation for a Equipment or Services, you must first register to become a Member and create your Account. Intermodal Pool does not own, license, operate, manage, provide access to, resell or maintain Equipment or Services. Intermodal Pool makes the Platform available so that Members can enter into transactions amongst themselves. We reserve the right to withdraw or amend the Platform, and any service, Content or other material we provide on the Platform, in our sole discretion without notice. We will not be liable if for any reason all or any part of the Platform is unavailable at any time or for any period. From time to time, we may restrict access to some parts of the Platform, or the entire Platform, to users, including registered Members.

INTERMODAL POOL HAS NO CONTROL OVER THE CONTENT CONTAINED IN ANY VENDOR PROFILES, OR ANY POSTINGS; THEREFORE INTERMODAL POOL MAKES NO REPRESENTATION OR WARRANTY REGARDING THE CONDITION, LEGALITY OR SUITABILITY OF ANY EQUIPMENT OR SERVICES BEING OFFERED. INTERMODAL POOL IS NOT RESPONSIBLE FOR, AND DISCLAIMS ANY AND ALL, LIABILITY RELATED TO ANY AND ALL VENDOR PROFILES, POSTINGS, EQUIPMENT OR SERVICES. ANY RESERVATIONS, AND RESERVATION AGREEMENTS (REGARDLESS OF WHETHER THE PARTIES USE INTERMODAL POOL'S RESERVATION AGREEMENT TEMPLATE), ARE MADE OR ACCEPTED AT THE MEMBERS OWN RISK.

You are responsible for:

Making all arrangements necessary for you to have access to the Platform..

Ensuring that all persons who access the Platform through your internet connection are aware of these Terms of Use and comply with them.

To access the Platform or some of the resources it offers, you may be asked to provide certain registration details or other information. It is a condition of your use of the Platform that all the information you provide on the Platform is correct, current, and complete. You agree that all information you provide to register with the Platform or otherwise, including but not limited to through the use of any interactive features on the Platform, is governed by our Privacy Policy, and you consent to all actions we take with respect to your information consistent with our Privacy Policy.

If we provide the capability to do so through our Platform, you may be able to register to become a Member by logging into your account with certain third-party social networking sites ("**3PS**"), such as Facebook. Each 3PS account is referred to as a "**Third-Party Account**". If we provide such functionality of the Platform, you may link your Intermodal Pool Account with Third-Party Accounts. This may occur if you: (i) provide your Third-Party Account login information to Intermodal Pool through the Platform; or (ii) allow Intermodal Pool to access your Third-Party Account (however, you will be limited by the applicable terms and conditions that govern your use of each Third-Party Account). You represent and warrant to Intermodal Pool

that you are entitled to disclose your Third-Party Account login information to Intermodal Pool and/or to grant Intermodal Pool access to your Third-Party Account (including, but not limited to, for use for the purposes described herein), without breach by you of any of the terms and conditions that govern your use of the such Third-Party Account, and without obligating Intermodal Pool to pay any fees or subjecting Intermodal Pool to any usage limitations. By granting Intermodal Pool access to any Third-Party Accounts, you understand that Intermodal Pool will access, make available and store (if applicable) any Content that you have provided to and stored in your Third-Party Account ("**3PS Content**") so that it is available on and through the Platform via your Intermodal Pool Account and Intermodal Pool Account profile page. Unless otherwise specified in these Terms of Use, all 3PS Content will be considered to be Member Contributions for all purposes of these Terms of Use. Subject to the privacy settings that you have set in such Third-Party Accounts, and depending on the Third-Party Accounts you choose and personal information that you post thereto, such personal information will be available through your Intermodal Pool Account and Platform. If a Third-Party Account or associated service becomes unavailable or Intermodal Pool's access to such Third-Party Account is terminated by the third-party service provider, then 3PS Content will no longer be available through the Platform. If you want to disable the connection between your Intermodal Pool Account and your Third-Party Accounts, you can do so at any time by sending a request to info@intermodalpool.com. Intermodal Pool makes no effort to review any 3PS Content for any purpose, including but not limited to for accuracy, legality or non-infringement and Intermodal Pool is not responsible for any 3PS Content. Your relationship with any third-party service providers associated with your third-party accounts is governed solely by your agreement(s) with them.

Your Intermodal Pool Account and your Intermodal Pool Account profile page will be created for your use of the Platform based upon the personal information you provide to us or that we obtain via a 3PS (as described above). You may not have more than one (1) active Intermodal Pool Account. If you create more than one (1) Intermodal Pool Account, or if any information provided during the registration process or thereafter proves to be inaccurate, fraudulent, not current, incomplete, or otherwise in violation of these Terms of Use, we may terminate, delay or suspend your Account.

If you choose, or are provided with, a user name, password, or any other piece of information as part of our security procedures, you must treat such information as confidential, and you must not disclose it to any other person or entity. You also acknowledge that your Account is personal to you and agree not to provide any other person with access to the Platform or portions of it using your user name, password, or other security information. You agree to notify us immediately of any unauthorized access to or use of your user name or password or any other breach of security. You also agree to ensure that you logout from your Account at the end of each session. You should use particular caution when accessing your Account from a public or shared computer so that others are not able to view or record your password or other personal information.

We have the right to disable any user name, password, or other identifier, whether chosen by you or provided by us, at any time in our sole discretion for any or no reason, including if, in our opinion, you have violated any provision of these Terms of Use.

Vendor Profile

Once you are registered as a Member, each Vendor shall create its Vendor Profile. As a Vendor, you will provide information regarding the Equipment or your Services. The characteristics of the available Equipment, availability, size, capacity, location hours of operation, pre and post trip requirements, the Reservation Fee, rules and regulations, types of insurance and certificates of insurance required from Customers, and other aspects regarding the available Equipment or Services. Once created, the Vendor Profile will be publicly available via the Platform and search results may place or rank your Vendor Profile depending upon many factors. To be fair to all Members, you agree that once a Customer requests a Reservation, you may not ask the Customer to pay a higher price than listed in the Vendor Profile.

As a Vendor, you agree that you, and not Intermodal Pool, are responsible for your Vendor Profile, including any Member Contributions that you may post. As a Vendor, you represent and warrant to Intermodal Pool that your Vendor Profile and any Reservation for Equipment or Services (i) will not breach any agreements made by you with third parties (e. g. , your landlord, lender, equipment provider, or other third party agreements), and (ii) will (a) be in compliance with all applicable laws, ordinances and rules, Tax requirements, intellectual property laws, and rules and regulations that may apply to any Equipment or Services included in your Vendor Profile (including having all required permits, licenses and registrations), and (b) not conflict with the rights of third parties. Intermodal Pool assumes no responsibility for Vendor's compliance with any agreements with or duties to third parties, applicable laws, rules and regulations. This Website facilitates transactions between businesses for business purposes. This Platform is not intended to be used by consumers for home or consumer-related purposes. Intermodal Pool reserves the right, at any time and without prior notice, to remove or disable access to any Vendor Profile for any reason, including those that Intermodal Pool, in its sole discretion, considers to be objectionable for any reason, in violation of these Terms of Use, or is otherwise harmful to the Platform. Any agreement that a Vendor enters into with a Customer for Equipment or Services is an agreement solely between Vendor and Customer and Intermodal Pool is not a party to that agreement.

Although Intermodal Pool may, directly or through third parties, ask you to provide personal information to help verify identity to Intermodal Pool, Intermodal Pool does not obtain such information or verifications for the benefit of Members; Vendors and Customers are required to provide accurate information, perform their own due diligence on Vendors, Customers, Equipment, and Services and Intermodal Pool is not responsible for any inaccuracies, misrepresentations, or omissions made by any Member.

Vendor agrees that Intermodal Pool does not provide insurance, act as an insurer and Intermodal Pool is not Vendor's agent. When Vendor creates or modifies its Vendor Profile, Vendor may specify certain requirements that must be satisfied by a Customer before Vendor will allow the Reservation of Equipment or Service and any Customer wishing to Reserve such Equipment or Service must satisfy Vendor's requirements to Vendor's sole satisfaction.

Intermodal Pool highly recommends that Vendors obtain appropriate insurance coverage for their Equipment and business, including but not limited to general and commercial liability as well as total Loss coverage arising from the use of Equipment by Customers. Vendors will want to consult with their insurance agents to determine that they have the proper coverage,

including knowing the exclusions and deductibles that may apply. Intermodal Pool recommends that, at a minimum, Vendor maintains and carries the following types and amounts of insurance:

(i) Motor truck cargo/terminal coverage with limits of not less than \$100,000 per unit and per occurrence,

(ii) Commercial General Liability policy of insurance (“**CGL**”) protecting Vendor and Intermodal Pool as an additional insured against claims for bodily injury, personal injury and property damage based upon or arising out of the ownership, use, occupancy or maintenance of the Equipment. Such insurance shall be on an occurrence basis providing single limit coverage in an amount not less than \$1,000,000 per occurrence with an annual aggregate of not less than \$2,000,000 with excess liability on following form basis of \$2,000,000;

(iii) Workers compensation in statutory amounts; and

(iv) Primary automobile liability insurance (“**Auto**”) with limits of not less than \$1,000,000 combined single limit covering owned, hired and non-owned vehicles used by Vendor.

The policies shall not contain any intra-insured exclusions as between insured persons or organizations, but shall include coverage for liability assumed under these Terms of Use an “insured contract” for the performance of Vendor’s indemnity obligations under these Terms of Use. The limits of said insurance shall not, however, limit the liability of Vendor nor relieve Vendor of any obligation hereunder. Vendor shall provide an endorsement on its liability policies which provides that its insurance shall be primary to and not contributory with any similar insurance carried by Intermodal Pool, whose insurance shall be considered excess insurance only. Insurance required herein shall be by companies maintaining during the policy term a "General Policyholders Rating" of at least A-, VII, as set forth in the most current issue of "Best's Insurance Guide, " or such other rating as may be required by a lender. Vendor shall not do or permit to be done anything which invalidates the required insurance policies.

By using the Platform, you agree that any legal remedy or liability that you seek for claims against other Members or third parties will be limited to such Members or third parties whom you believed caused the harm which led to your claim, and there will be no recourse against Intermodal Pool. You agree that you will not attempt to impose liability whatsoever or seek any legal or equitable recourse against Intermodal Pool regarding such claims.

Reservations/Financial Terms

Intermodal Pool charges Vendors a Service Fee for the use of the Platform. Customers must pay all Reservation Fees through the Platform via Stripe. Intermodal Pool collects such payments solely as a limited payment collection agent for the applicable Vendor. After Customer has made such payment for the Reservation Fee to Intermodal Pool through Customer’s Stripe account, the IMP Fee is deducted from Reservation Fee by Intermodal Pool and the remaining balance is then disbursed to the Vendor through Stripe. Vendor is solely responsible for determining, charging, collecting, reporting, and remitting any and all Taxes applicable to a Reservation or Reservation Agreement. Vendors will receive a communication of the Reservation details. If a Vendor or Customer makes any modifications to the Reservation in accordance with the terms set forth herein, then Vendor and Customer agree to pay any changed or additional Reservation Fees and IMP Fees and Vendor agrees that any changed or additional IMP Fees shall be paid to Intermodal Pool. Vendor and Customer agree that any applicable Taxes collected by Vendor shall be paid by Vendor to the applicable Taxing authority.

Payment Collection Agent. Intermodal Pool acts solely as a limited payment collection agent for Vendors. Receipt of payment by Intermodal Pool satisfies the Customer's payment obligation to the applicable Vendor. Intermodal Pool does not act as the seller, lessor, or retailer of Equipment or Services. Customer acknowledges that Intermodal Pool may appear on Customer's bank or card statements as the payment processor or payment collection agent for Vendors.

Vendors. If you are a Vendor and a Customer submits a Reservation Request for your Equipment or Service, you must either (i) accept, which will be the Confirmed Reservation; or (ii) reject the Reservation Request. If Vendors do not confirm, or decide to reject, a Reservation Request, or if Customer cancels its Reservation Request (e. g. , because Vendor has not accepted or rejected), then no payment shall be made by Customer to Intermodal Pool. When a Vendor confirms a Reservation Request, Intermodal Pool will send Customer a Communication of such Confirmed Reservation. Pursuant to the Confirmed Reservation, Vendor and Customer enter into a Reservation Agreement for the Equipment or Service. Vendor agrees that Intermodal Pool is not a party to the Reservation Agreement, that Vendor alone is responsible for its contents, terms and conditions (regardless of whether Vendor chooses to use Intermodal Pool's forms or templates, if provided) and for performing the obligations of Vendor, and that Customer alone is responsible for performing the obligations of Customer, under the Reservation Agreement. Intermodal Pool disclaims all liability with respect to any Reservation Agreement, regardless of whether Intermodal Pool has provided forms or templates for use in connection with the Platform.

Upon the Vendor's Reservation Confirmation, Customer will initiate payment of the Reservation Fees to Intermodal Pool. Each Vendor expressly authorizes Intermodal Pool's service provider, Stripe, to originate credit transfers to your financial institution account. Each Vendor further authorizes Intermodal Pool to take any actions reasonably necessary to effectuate the transfer of funds in accordance with these Terms of Use, the Website, and the Reservation Agreement.

Customers. Customers agree that Vendor Profiles are posted by Vendors and that Vendors are solely responsible for honoring Confirmed Reservations and making the Equipment or Services available to the Customer. Customer acknowledges and agrees that Customer enters into the Reservation Agreement with the Vendor, and not with Intermodal Pool. Customer agrees that Intermodal Pool is not a party to the Reservation Agreement, that Customer alone is responsible for performing the obligations of Customer, and that Vendor alone is responsible for the content of, and for performing the obligations of Vendor, under the Reservation Agreement (regardless of whether Vendor chooses to use Intermodal Pool's forms or templates, if provided). Customers agree that they will abide by the terms and conditions contained in the Reservation Agreement, as well as any rules and regulations specified by the Vendor regarding the access to and use of the Equipment or Service. This Platform facilitates transactions between businesses for business purposes. This Platform is not intended to be used by consumers for home or consumer-related purposes. Accordingly, Equipment shall not be included in any Vendor Profile, or used, for any criminal or immoral purposes, or, unless otherwise set forth in the Reservation Agreement, used for habitation, for cooking or sleeping purposes, or for any consumer-related purposes. Intermodal Pool disclaims all liability with respect to any Reservation Agreement.

The Website will display to a potential Customer the Reservation Fees payable before the

potential Customer sends a Reservation Request to a Vendor by clicking the “Purchase” (or similar) button. Vendor is required to either confirm or reject the Reservation Request via the Platform. If Vendor does not confirm or reject a Reservation Request, then at any time prior to Vendor’s acceptance/confirmation or rejection of Customer’s Reservation Request, Customer may cancel its Reservation Request and no payment shall be made by Customer to Intermodal Pool. Depending on how a Vendor chooses to charge for their equipment, ongoing charges may be processed on the Customer’s payment method of choice. By sending a Reservation Request, Customer is agreeing to allow Vendor to process ongoing daily payments for any unreturned Equipment. Customer will be given no less than 24 hours to dispute any daily charges that will be processed.

Customer agrees to pay the Reservation Fees for any Confirmed Reservation. Upon the Vendor’s Confirmed Reservation, Customer’s payment of the Reservation Fees will be made to Intermodal Pool via Stripe. When your Confirmed Reservation transaction is complete, Customer will receive a Communication summarizing your Confirmed Reservation.

In order to use the Stripe payment functionality of the Intermodal Pool Website, you must open a Stripe account provided by Stripe and you must accept the Stripe Terms and Privacy Policy. Any funds held in the Stripe account are held by Stripe’s financial institution partners as set out in the Stripe Terms. You authorize Intermodal Pool to collect and share with Stripe your personal information including full name, physical address, email address and financial information, and in the case of accredited accounts or when otherwise requested by Intermodal Pool, date of birth and social security number, and you are responsible for the accuracy and completeness of that data. You understand that you will access and manage your Stripe account through Stripe directly, and Stripe account notifications can be sent by Stripe or Intermodal Pool to you. Intermodal Pool will provide customer support for your Stripe account activity, and can be reached at info@intermodalpool.com

Cancellations and Refunds

Customer may cancel a Confirmed Reservation by submitting a written request to info@intermodalpool.com no later than twenty four (24) hours prior to the start date of the Reservation and in such event the Reservation Fee shall be refunded to Customer. Any cancellations to a Confirmed Reservation less than 24 hours prior to the start date will not be subject to a refund. In such event, the Customer shall owe the full amount of the Reservation Fee for the Confirmed Reservation. Notwithstanding the foregoing, in the case of recurring monthly or weekly Reservation (as may be set forth in the Confirmed Reservation), a Customer must provide notice of cancellation no later than twenty-four (24) hours prior to the first day of the following month or week, respectively. Failure to provide such notice will result in Customer being responsible for the full monthly or weekly Reservation Fee, as relevant, for the following month or week, respectively.

Vendors are not entitled to cancel a Confirmed Reservation, but must honor the same.

Any refunds or credits shall be settled solely between Vendor and Customer and Intermodal Pool shall not be obligated whatsoever with respect thereto. Intermodal Pool shall serve as a third-party facilitator of any refund or credit agreed upon between Vendor and Customer. For the avoidance of doubt, Intermodal Pool shall in no event be liable for any refund or credit agreed upon by and between Vendor and Customer.

In certain circumstances, Intermodal Pool may decide, in its sole and absolute discretion, that it is necessary or desirable to cancel a Confirmed Reservation made via the Platform or that a Customer will be refunded all or a portion of the amounts charged to the Customer. In such events, Vendors agree that neither Intermodal Pool nor Customer will have any liability for such cancellations or refunds.

The Customer and Vendor acknowledge and agree that credit card fees paid in relation to a reservation are non-refundable. In the event that a credit card fee was charged for a reservation, and the reservation was, at a later time, refunded, the [Customer or Vendor] shall be liable for the original credit card fee.

Taxes

Applicable tax laws may require that Intermodal Pool collect certain tax information from Vendors and provide the same to the taxing authorities, withhold Taxes from remittances to Vendors, or do both. For example, that may include an IRS Form W-9 and/or similar State forms. Vendors are solely responsible for maintaining accurate, current and correct information on tax forms. Vendors and Customers are solely responsible to determine their applicable Tax reporting requirements, the amount of Taxes that should be included relating to the applicable Taxes specified in Vendor Profiles and for remitting to the relevant taxing authority such applicable Taxes that are due and payable by Vendor or Customer.

Intermodal Pool does not calculate, assess, or remit sales, use, or similar transaction-based Taxes on behalf of Vendors.

Damage

Customer agrees that (i) it is solely responsible for its own, as well as its employees, agents, guests, invitees, or visitors, actions or omissions, including but not limited to theft, personal injury or death or property damage; (ii) it shall return the Equipment in the same condition it was in when the Customer received it. If a Vendor makes a claim that the Customer violated the foregoing requirements, Customer agrees to pay the cost of repairing, replacing and restoring the Vendor's Equipment damaged or stolen by Customer, its employees, agents, guests, invitees or visitors ("**Repair**"). Additionally, Customer agrees that claims under Customer's insurance policies may be made related to any such damages, destruction or Repair and Customer agrees to provide Vendor (and to Intermodal Pool, upon its request) with such information as may be necessary in order to make such a claim, and Customer shall take such acts as may be reasonably requested to make and further such claim. Vendor and Customer agree that any claim regarding damages or destruction of the Vendor's Equipment, any dispute

regarding Repairs, shall be solely between Vendor and Customer; and Vendor and Customer each hereby release Intermodal Pool Parties which shall have no liability or obligation whatsoever with respect thereto. Each of Vendor and Customer shall indemnify, defend and hold Intermodal Pool Parties harmless from and against any and all Losses in any way arising out of or regarding damages or destruction of the Vendor's Equipment or Repairs. Intermodal Pool highly recommends that Customers obtain appropriate insurance coverage and consult with their insurance agents to determine that they have the proper coverage, including knowing the exclusions and deductibles that may apply.

Holdover

Customer agrees that a Reservation Agreement is merely a revocable license granted by the Vendor to Customer, whereby Vendor makes the Equipment available to Customer for the limited time period, and under other terms and conditions as specified in the Confirmed Reservation and Reservation Agreement. As such Customer agrees that it is not entitled to use the Equipment prior to the start date, or beyond the end date, unless Vendor and Customer enter into a Reservation Agreement for the additional time, with the appropriate additional Reservation Fees having been paid through the Platform. This is because, in part, Vendor may have entered into other Reservation Agreements for the license of the Equipment to other users to commence prior to the start date or after the end date. If Customer keeps the Equipment beyond the end date of a Reservation (such overstay, a "**Holdover**"), then Customer no longer has the license granted under the Reservation Agreement, which license terminated upon the end date and Vendor is entitled under the Reservation Agreement and applicable law to demand immediate return of Equipment by Customer. Customer agrees that if reserved Equipment is not returned as of the End Date specified in the Reservation Confirmation, Vendor has the right, without further notice to or consent of Customer, to adjust the End Date within a period of ten (10) days after reserved Equipment is returned to the Vendor in order to obtain payment from Customer of such additional Reservation Fees for any additional days beyond the original End Date. In the event of a Holdover, Intermodal Pool shall be entitled to payment of the IMP Fee, as calculated based upon the additional days beyond the original End Date.

If Customer returns the Equipment prior to the originally scheduled End Date under a Reservation Agreement, there will be no refund for any unused days in the original Confirmed Reservation.

Any refunds or credits shall be settled solely between Vendor and Customer and Intermodal Pool shall not be obligated whatsoever with respect thereto. Intermodal Pool shall serve as a third-party facilitator of any refund or credit agreed upon between Vendor and Customer. For the avoidance of doubt, Intermodal Pool shall in no event be liable for any refund or credit agreed upon by and between Vendor and Customer.

Intellectual Property Rights

The Platform and its entire Contents, features, and functionality (including but not limited to all information, software, text, displays, images, video, and audio, and the design, selection, and arrangement thereof), are owned by Intermodal Pool, its licensors, or other providers of such material and are protected by United States and international copyright, trademark, patent, trade secret, and other intellectual property or proprietary rights laws.

Subject to your compliance with these Terms of Use, Intermodal Pool grants you a limited, non-exclusive, non-transferable, non-sublicensable license, solely for your personal, non-commercial use (i) to use the Platform; (ii) to download and install a copy of the Platform on each mobile device (if a mobile application is made available for such use) or computer that you own or control and run such copy of the Platform solely for your own personal use; and (ii) to access and view any Customer Content which you are permitted to access. If this Platform is made available for access or download via the Apple App Store, you will do so only (i) on an Apple-branded product that runs the iOS (Apple's proprietary operating system) and (ii) as permitted by the "Usage Rules" set forth in such Apple App Store Terms of Service.

You must not:

Modify copies of any materials from this Platform.

Delete or alter any copyright, trademark, or other proprietary rights notices from copies of Contents or other materials from this Platform.

You must not access or use for any commercial purposes (other than your own use of the Equipment) any part of the Platform, any Content, or any services or materials available through the Platform.
