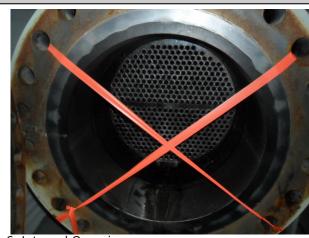


Photo 6: Internal Overview

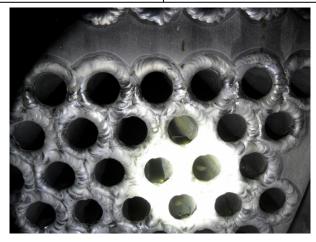

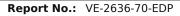
