Observations:

✓ Vessel in Good Condition

■ Based on API 510 Visual Internal Inspection this vessel is fit for service

- The manway flange and cover plate sealing areas are in good condition. There are no concerns. The davit arm has two nuts but it is not double nutted.
- All internal welds (nozzles, Circ. and Long. welds, demister support bars, waterboot Circ. and Long. weld) are in good condition. There is no corrosion, erosion or preferential attack noted. The longitudinal weld in Can 1 (south one) is on the East side (3 O'clock) and the one in Can 2 is on the West side (9 O'clock). The inlet nozzle protrudes into the vessel and the flow is directed towards the south head. There are no issues of erosion noted on the south head.
- The heads have mill scale still present on the surfaces. There are no issues. The shell walls have slight surface roughening of approximately 0.005 inch.
- The waterboot has a coil inside of it. There is no corrosion, erosion or pitting noted on the coil. There are no concerns. There is minor debris found on the bottom head. Operations were notified and they vacuumed out.
- The front demister pad was cleaned and put back into service. The demister baffle plates were removed and another demister pad was installed and the demister support was modified to accommodate the rear demister pad.
- Measured from the South end of the waterboot (at the 6 O'clock position, bottom of vessel), there are isolated pitting at the 19 and 22 inch mark both at $\frac{1}{4}$ inch in diameter and 0.050 inch deep. At the 21 inch mark, there is a 0.020 inch deep isolated pit that is 3/16 inch in diameter. At the 48 inch mark, there is a $\frac{1}{4}$ inch diameter by 0.050 inch deep pit.
- Measured from the South end of the demister support bar at the 20.5 inch mark on the West side at the 9 O'clock position, there is a mechanical damage that is 0.040 inch deep x 1/8 inch wide x 1 $\frac{1}{2}$ inch long.
- Measured from the can 1 to can 2 Circ. weld at the 21 inch mark on the West side at the 9 O'clock position, there is a mechanical damage that the deepest indication is 0.050 inch deep x 3/16 inch wide x 1 1/4 inch long. Just south of this, approximately 4 inches and 5 inches up towards the top of vessel, there is a fold of shell material caused by mechanical damage approximately 1 inch in length.
- There are fit-up marks present still in the cans at the can 1 to can 2 Circ. weld. There are no concerns.
- On the shell side of can 2 (north can) up at the 2 O'clock position, there is a buffed area and there are no concerns.
- The vortex breaker is intact by the north end of can 2. There are no concerns.

Recommendations:

- Put a second nut on the top of the support rod for manway cover plate to double nut it.

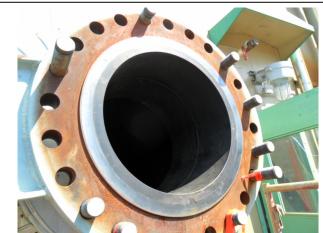

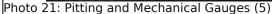




Photo 22: Buffing Area on Shell in Can 2

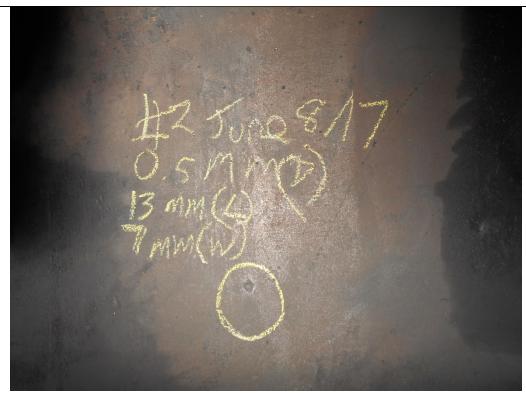


Figure 7 Pit #2

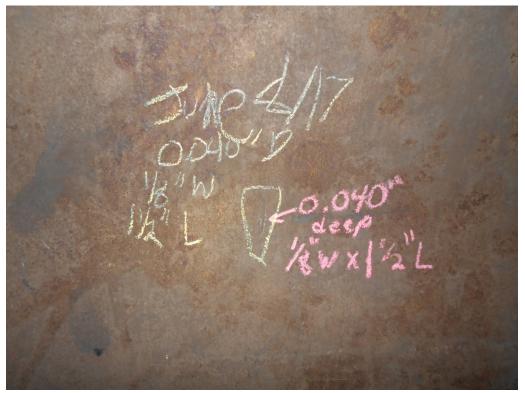


Figure 12 Pit #4
