**Grounding Device in Place and Secure?:** N/A, the equipment is grounded through the skid. Vessel was not in service at the time of this inspection.

**Condition of Foundation and Anchor Bolts:** There are no anchor bolts. The support skirt is welded to a baseplate, which is welded to the skid deck/frame. Baseplate-to-deck/frame attachment welds appear sound. The (2) vertical supports are in anchored to the skid/trailer deck/frame.

**Condition of Steel Supports, Saddles, and Bolting:** The (2) vertical supports have no corrosion or distortion. All support structural welds appear sound.

**Condition of Paint and/or Insulation:** The paint is in acceptable condition with minor localized chipping and peeling.

**Condition of Nozzles, Flanges, Repads, and Weepholes:** Nozzles and flanges are in good condition. All flange bolting is in place and secure.

**Condition of Welds; Head and Shell Metal Surfaces:** All (exposed) metal surfaces are painted. There is no distortion or indication of corrosion beneath the paint coating. The pressure boundary welds have no visual weld defects. Paint has minor chipping.
