TACK WELDS

Tack welds may be used on welded parts to hold edges in proper alignment until final welds are made and shall use an appropriate qualified welding procedure.

REMOVAL

Insofar as practicable, tack welds shall be removed completely when they have completed their purpose. Removal shall be by grinding and shall completely remove tack weld material exposing sound base metal. Surfaces shall be inspected by the welder to be free from defects as to prevent inclusion of any impurities into the weld joint.

INCORPORATION

Tack welds to be left in place shall be:

- (a) made by qualified welders to an appropriate qualified welding procedure.
- (b) made at the root of the joint with the same electrode as that used in the root pass.
- (c) completely fused with the root pass.
- (b) cleaned to sound metal and blended into surrounding metal along their entire length.
- (b) satisfactorily visually inspected by the welder before incorporation into the final weld. Inspection shall be over the entire length of the tack weld (including stopping and starting ends) and shall ensure full fusion, complete penetration and that it be free from defects (slag, cracks, porosity etc).

If found to be defective, tack welds shall be removed as outlined above.

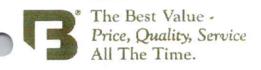
STOPS & STARTS

If welding is stopped for any reason, extra care shall be taken in restarting. The stops / starts shall be ground to secure sound metal at the base of weld metal first deposited. Edges shall be blended into surrounding metal and ends feathered to produce a continuous groove surface free from abrupt ridges, valleys or discontinuities. Welders shall inspect stops and starts before incorporation into the final weld to ensure it be free from any defects and that it allows full penetration and complete fusion to the existing stop / start.

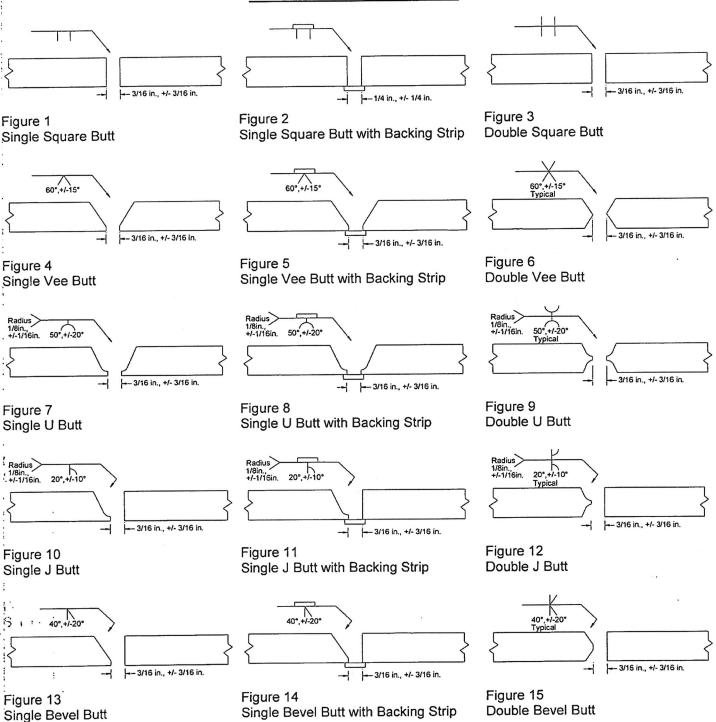
