


FIGURE 1 SINGLE SQUARE BUTT









SINGLE SQUARE BUTT




FIGURE 2 SINGLE SQUARE BUTT WITH BACKING STRIP



DOUBLE SQUARE BUTT




FIGURE 4 SINGLE VEE BUTT



WITH BACKING STRIP



DOUBLE VEE BUTT




FIGURE 7 SINGLE U BUTT



WITH BACKING STRIP



FIGURE 10 SINGLE J BUTT



WITH BACKING STRIP




FIGURE 12 DOUBLE J BUTT




FIGURE 13 SINGLE BEVEL BUTT




FIGURE 14 SINGLE BEVEL BUTT WITH BACKING STRIP

Single Square Butt









Figure 13 Single Bevel Butt


